Factors to Investigate Before Suing Your Customer



Last week we talked about how to decide if you should sue a business for unpaid invoices. We focused on Return on Investment (ROI) as the primary criterion. This week we are discussing

facts and circumstances to consider when evaluating ROI and how ROI expectations have changed over the last few years.

Since the beginning of the financial crisis in 2008, we have seen five major changes impacting key factors in the ROI equation on many of the cases we evaluate:

- The Real Estate Bust
- Weaker Economy
- Improvement in Information Availability
- Slower Court Process
- Higher Court Costs

Business owners are far more likely to own real estate than the average American. This used to be a positive indicator that an owner had personal assets available that they could tap to cover business obligations. Even if our clients didn't have a personal guaranty, we could expect that eventually during the judgment collection process, we could put so much pressure on the business that the owner would prefer to inject personal funds instead of having business assets seized. Many business owners had used historical profits to finance real estate investment beyond their primary home, giving them more personal assets to access as our pressure increased. *Continue Reading.*
